SH&FPA aims to drive and contribute to international, national and state policy agendas to create and maintain a high profile for sexual and reproductive health issues.

SH&FPA spokespeople are prominent and sought-after commentators on a range of issues relating to sexual and reproductive health.

SH&FPA lobbies key parliamentarians to ensure that Australians' sexual and reproductive health rights are enhanced and protected.

SH&FPA participates in a range of international conferences, forums and policy development platforms on international sexual and reproductive health.

SH&FPA works actively to increase access to comprehensive sexual and reproductive health services which are unbiased and emphasise individual choice.

Member family planning organisations provide an extensive range of services to people who have difficulty accessing mainstream services. These include marginalised young people, people with disabilities, indigenous Australians and people from culturally and linguistically diverse communities.

Over 60,000 people annually attend clinical services provided by member family planning organisations.

Over 19,000 health and human service professionals participate in sexual and reproductive health workforce education and training programs provided by family planning organisations every year.

Family planning organisations provide sexual and reproductive health promotion activities to over 81,000 participants in Australia annually.

SH&FPA is well positioned as a leader in sexual and reproductive health in Australia.

SH&FPA maintains a high level of exchange of information and expertise among organisations focused on sexual and reproductive health issues.

SH&FPA has worked closely with key organisations to establish Reproductive Choice Australia (RCA), a coalition of organisations and individuals committed to protecting and enhancing women's reproductive rights in Australia.
